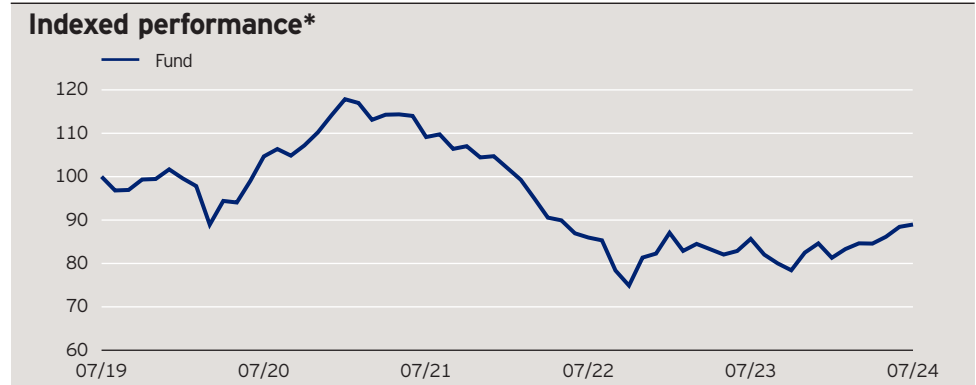
Investment risks

Fund Strategy

The fund aims to generate income and long term capital appreciation from investment in Asia-Pacific equities and debt securities (excluding Japan). Our approach to asset allocation is flexible and, based on a clearly defined investment process and risk overlay, aims to reduce downward risk and volatility (although this is not guaranteed). Within equities, we look for companies with sustainable value and competitive advantages. Within fixed income, we aim to maintain a diversified and high-quality portfolio that helps generate income.

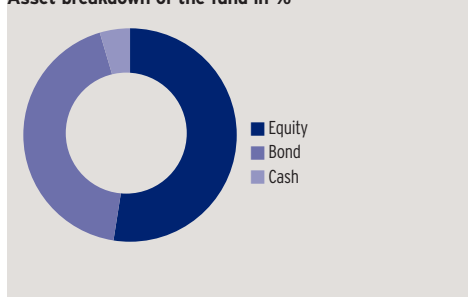
